Structure, Governance and Management

The Charity was registered on 2 July 1999. The group was previously known as Friends of Biddle Street SSSI, which was an informal association with managementresponsibilities for an area of land in the parishes of Yatton and Congresbury in North Somerset. Membership of the Charity is open to individuals and organisations who are interested in furthering the work of the Charity and who have paid any subscription laid down from time to time by the Executive Committee.

Objectives and Activities

The Charity's objects are to establish and maintain nature reserves in the parishes of Yatton and Congresbury for the benefit of the public and to advance education in natural history and nature conservation.

YACWAG has an active membershipwith a wide array of relevantskills and expertise in voluntary organisation and nature conservation. YACWAG's public activities were curtailed due to the Covid19 pandemic, in particular dormouse and bat surveys, public walks and public meetings. The AGM was cancelled in accordance with guidance from the Charity Commission. However, meetings of the Trustees continued via Zoom.

Achievements and Performance 2020/2021

Despite the Covid restrictions YACWAG has been able to achieve outcomes in most key areas of its work. A five-year Countryside Stewardship (higher tier) grant was secured from 1 January 2021. Work commenced a ditch and scrub management plan on the Strawberry Line Local Nature Reserve (LNR) in agreement with Natural England.

A smallappleorchard was planted at Kenn Moor reserve through the financial support of the charity's members. An oak tree was also planted at Harry's Plot, Claverham, sponsored tocommemorate two lifelong friends who had lived in Claverham. A total offour owl boxes were put up. Two were replacements on YACWAGreserves and twodonated by member Barbara Evanswereerected on Cadbury Hill LNR. A total of 54 bird boxes were checked on YACWAG reserves, Strawberry Line LNR, Glebelands and St Mary's churchyard, Yatton.

A regular fungussurvey was establishedat Littlewoodthanks to the Bristoland North Somerset Fungus Group. Bird surveys were carried outunder the supervision of Trevor Riddle on the Strawberry Line, Littlewood and other reserves in connection with the North Somerset Moors and Levels Project. Although curtailed by Covid restrictions, 21 out of 27 planned surveys were carried out. In addition, members were encouraged to report their bird sightings and send photos for circulation to the wider membership via email. This proved very popular throughout the lockdown periods. The Christmas bird survey had a record response from over 100 residents and members.

YACWAG received publicity in the local press and radio through the discovery of the rare Yellow Loosestrife Bee at the Stowey reserve. The discovery of a rare horseflyat the CongresburyMoor reserve three yearsagoby Colin Higginsreceived recognition through a paper published in the British Journal of Entomology.

Spring and autumn newsletterswere published together with three additional special editions focusing on insects and the flora and fauna of NewCroft.



Membership of the Charity has been maintained at approximately 250 and the YACWAG Facebook Group reached a total of just over 400. The website was updated by Mark Stanfordto be compatible formobile phone users.

Although public events were largelyabandoned, YACWAG had a presence at the Congresbury "virtual" village fete and Sue Loveseyorganised a socially distanced tree dressing event at St Andrew's schoolbased on an idea by Chloe Brown. Aprogramme of online public talks was organised through Zoomwhich started with a presentation by Nikki Jones of Avon Needs Trees. YACWAG purchased a licence for Zoomwhich also enabled online discussions between trustees and others. The executive committee met via Zoom on four occasions and its work included a review and update of its policies, financial reporting and banking arrangements and updating its 5 Year rolling planto develop a resilient approach to Covid and the sustainability of the charity.

Discussion continued with North Somerset Councilassisted by Graham Loveseyregarding the transfer of land in Congresbury as part of a section 106 planning agreement to provide mitigation for Greater Horseshoe Bats.

YACWAG has engaged with a number of organisations and groups throughout the year. These have included assisting Cleeve church prepare a draft management plan for its churchyard to achieve an A Rocha Eco Church Bronze Awardas well as sharing information and experience with Avon Needs Trees regarding Charity management and organisation and setting up surveys at Littlewood with the Bristol and North Somerset Fungus Group. There was liaison with the Meadowview residents' group in Claverham to plant an oak tree on Harry's Plot.

YACWAGwas grateful for the support of its membership, volunteers, local contractors and graziers, especially Patrick Vincent of Green Mantle, Andrew and Joe Hunt, Andy Milward, Steve Devine, Colin Higgins, James Brineand Trevor Richardsto bring about the work mentioned above and help YACWAG makea real difference for nature.



INDEPENDENT EXAMINER'S REPORT

I report on the accounts of the Charity for the year ended 28 February 2021.

Threeadditional accounts have been opened during the year in accordance with YACWAG's Investment Strategy.

Fixed Assets held by the Charity

- 10 Acre field on Congresbury Moor, purchased in 1999 for £24,900 plus costs.
- 2 additional fields (New Croft and Meakers) on Congresbury Moor, purchased in 2000 for £17,725 plus costs.
- Phippens (field) on Congresbury Moor, purchased in November 2001 for £5000 plus costs.
- Littlewood (woodland), Claverham Drove, Kenn Moor, purchased in 2003 for £19,000 plus costs.
- 2 fields off Stowey Road, Yatton, purchased in 2006 for £25,000 plus costs.
- 2 fields off Kenn Moor Road, Yatton, purchased in 2006 for £42,700 plus costs.
- Footmead (field) on Congresbury Moor, purchased in 2007 for £4,000 plus costs.
- Nortons, field on Congresbury Moor, purchased in 2009 for £12,000 plus costs.
- Harry's Plot off Claverham Close, Claverham, bequeathed in 2017.

The freehold title to the above properties, with the exception of Nortons, is held on trust for the Charity by the Official Custodian for Charities.

ContingentLiability

The land off Moor Lane known as Nortons is subject to a legal charge in perpetuity of 58.3% of the sale price in the event of any sale.

YACWAG also holds conservation tools and equipment with an estimated value of £5,431.

1Receipts and Payments Basis

Section 133 of the CharitiesAct 2011allows a charity to prepare a 'receipts and payments account' for the year and a 'statement of assets and liabilities' at the year-end instead of preparing full accounts for a particular financial year on condition that in the financial year the charity's gross recorded income was £250,000or less and it is not a company.
