Structure, Governance and Management

The Charity was registered on 2 July 1999. The group was previously known as Friends of Biddle Street SSSI, which was an informal association with management responsibilities for an area of land in the parishes of Yatton and Congresbury in North Somerset. Membership of the Charity is open to individuals and organisations who are interested in furthering the work of the Charity and who have paid any subscription laid down from time to time by the Executive Committee.

The Charity is administered by an Executive Committee. Yatton Parish Council and Congresbury Parish Council each have the right to nominate one member of the Executive Committee. The AGM, at its meeting on 23 May 2018, agreed to amend the Constitution to remove the right for the Cheddar Valley Railway Walk Society (now the Strawberry Line Society) to nominate a member to the Executive Committee. It was also agreed at that meeting to create the office of Vice Chairperson, to be elected together with the Chairperson, Secretary and Treasurer from the membership at the AGM. Additionally up to four members may be co-opted by the Executive Committee.

The Executive Committee may exercise powers in furtherance of the objects, including power to raise funds and to invite contributions, power to buy, sell, lease, exchange and equip property, power to employ staff, power to co-operate with other bodies of similar purpose and power to establish and support any charitable trusts, associations or institutions for all or any of the objects. They have power to appoint and constitute appropriate advisory committees, but do not have the power to undertake any substantial permanent trading activities.

The Executive Committee has a policy with regard to the recruitment, induction and training of Committee members. This policy endeavours to ensure that individuals with an interest in the works of the Charity, with appropriate skills or expertise, are recruited, appointed and subsequently adequately versed in the affairs of the Charity and the responsibilities of Charity trusteeship.

The Executive Committee annually reviews the major risks facing the Charity. It is satisfied that appropriate systems are in operation to mitigate those risks. Specifically, as part of this process, the Executive Committee has considered that the changes to the financial reporting using an easily accessible computerised accounts system and online payment system since 2017/18 have proven very effective. A considerable amount of time and effort was spent on amending administrative systems to comply with the General Data Protection Regulations in May 2018. The Executive Committee carries out regular reviews of its policy framework. Policies relating to land acquisition, reducing environmental impact and safeguarding were updated.

It was agreed that YACWAG should actively seek to build contingency funds to assist with land purchase and also towards land management due to the uncertainty regarding the future of agri-environmental grants. A decision was also taken to invest financial reserves in an interest-earning account with the Charity Bank. Strategic management has been assisted by the adoption of a rolling five-year plan by the Executive Committee.

Objectives and Activities

The Charity's objects are to establish and maintain nature reserves in the parishes of Yatton and Congresbury for the benefit of the public and to advance education in natural history and nature conservation.

YACWAG has an active membership with a wide array of relevant skills and expertise in voluntary organisation and nature conservation. In addition to fundraising, members organise practical work parties, walks, talks, school visits, events, species surveys and training. YACWAG provides advice and support to landowners, individuals and voluntary organisations. New educational activities and scientific research are encouraged. Since its inception YACWAG has created four nature reserves through land purchase (on Biddle Street SSSI, Kenn Moor SSSI and Stowey fields.) Members are responsible for land management and liaison with relevant agencies to achieve biodiversity objectives and targets.

YACWAG works with a wide network of agencies and voluntary organisations involved with nature conservation in North Somerset. It is represented on the Strawberry Line management committee and continues to develop strong links with Natural England in the management of its nature reserves on two Sites of Special Scientific Interest. YACWAG works closely with the Hawk and Owl Trust and is an active member of the North Somerset Nature Net. YACWAG is also affiliated to TCV, the national conservation organisation for voluntary groups. Many of YACWAG's active volunteers are also associated with other local voluntary projects, for example, the Friends of Yatton Station Garden.

Achievements and Performance 2018/2019

YACWAG's financial position remains healthy with a small surplus for the second year running. This has been achieved despite another significant delay in the receipt of agrienvironmental payments beyond the end of the annual accounting year. However, unlike the previous two years when conservation work had to be postponed, the weather did not prevent the planned conservation programme. Ditching and scrub removal was carried out on the Congresbury Moor Reserve and the Strawberry Line. Part-funding for this work came through a grant from the Avon Wildlife Trust. The rather inclement weather did, however, probably account for the poor breeding of barn owls for a successive year with only one brood of two chicks being recorded.

YACWAG volunteers participated in over 30 work parties amounting to over 600 hours of practical conservation work on YACWAG reserves and public open spaces including the Strawberry Line Local Nature Reserve. Regular activities included checking bird and bat boxes and associated maintenance and surveys. YACWAG is particularly grateful to Alan Walker for masterminding the construction and erection of two replacement barn owl boxes on Congresbury Moor with the assistance of Andrew and Joe Hunt. A day of hedge-laying was organised on Congresbury Moor for Costain employees under the expert eye of Malcolm Dowling as part of the company's engagement with the community programme.

A programme of six walks enabled the public and members to discover wildflowers at the Stowey Reserve, bats on Cadbury Hill and birds of the Strawberry Line and Kingston Seymour. A talk on dormice drew an audience of 40 people who learnt about the discovery of dormice locally and the regular surveys carried out by YACWAG volunteers thanks to the leadership of Sarah Dale.

YACWAG maintains a close relationship with Saint Andrew's school, Congresbury. Volunteers took part in an assembly to promote the Big Bird Watch, carried out a bird box check in the school grounds and put up an insect house. A YACWAG stall was run at a memorial event for the late headteacher, Neil Tuttiet. Participants were able to make up insect house kits for the memorial garden at the school and also one to use in their own gardens. They also learnt about the importance of insect pollination.

A YACWAG "Hungry Caterpillar "stall was run at the Yatton Schools' summer carnival and provided an introduction to the magical world of butterflies and moths under the banner *Nature as your Neighbour*. This slogan has been adopted for all YACWAG events and promotional material when reaching out to the wider community about the importance of nature conservation and the charity's work in the two parishes. YACWAG has an experienced and enthusiastic bat group carrying out regular surveys in the two parishes and surrounding areas. Some members of this group attended two Batlinks meetings organised by Natural England in order to develop and coordinate bat data mapping in the Mendip region to guide planning and development mitigation. The group undertook its regular annual surveys for the Bat Conservation Trust National Bat Monitoring Programme in Claverham and Congresbury. Group members also assisted residents in Cleeve with the collection and analysis of horseshoe bat records which are required to make informed planning objections.

Two quizzes were held at the Plough Inn, Congresbury, which raised £345. The traditional Tree Dressing was carried out in Yatton and Congresbury in December using 'eco-bricks' to discourage single-use plastic. The eco-bricks and some other hanging environmental slogans were made by different youth groups from the two villages. YACWAG received national publicity in January 2019 when the Chairperson was interviewed about the charity's work on the BBC Radio 4 Open Country programme.

An extraordinary amount of additional work was carried out by our Secretary and other committee members to ensure that the charity was compliant with the revised data protection requirements (GDPR) introduced in May 2018.

YACWAG is grateful to all its members, volunteers, sponsors and supporting organisations in helping it achieve so much in the past year. Special thanks are due to Andy Millward and Steve Devine for providing cattle grazing on our reserves. Our thanks also go to Andrew Hunt, Green Mantle and Trevor Richards for assisting with our conservation works and land management. We are also are grateful for the continued support of Chris Sperring, Hawk and Owl Trust, with barn owl monitoring.

The Freehold title to the above properties, with the exception of Nortons, is held on trust for the Charity by the Official Custodian for Charities.

Contingent Liability

The land off Moor Lane known as Nortons is subject to a legal charge in perpetuity of 58.3% of the sale price in the event of any sale. However the validity of this legal charge is being re-examined due to the winding up of Yanley and North Somerset Environmental Company.

The Charity also holds conservation tools and equipment with an estimated value of £7,320.
